Order what your shop will sell. Mix the two SKUs any way you like.

Invoiced

Paid online through Shopify. First order prepaid, then Net 30.

2 days

To the carrier, out of Newport Beach.

These terms cover every Swips wholesale account. Placing an order or paying an invoice means you have read them and accept them. Nothing to sign. They replace the terms dated September 11, 2026.

01 PRICING

Launch pricing is firm through December 31, 2026. We give 60 days written notice before any price change.

02 PAYMENT

We invoice every order through Shopify. You pay the invoice online by card or bank transfer. There is no account to set up and we do not keep a card on file.

Your first order is prepaid. The invoice goes out when we confirm the order and the order ships once it is paid.

From your second order on you are on Net 30. The invoice goes out with the shipment and is due 30 days from the invoice date. Past due balances carry 1.5% per month, and an account with an invoice more than 15 days past due goes back to prepaid until it is current.

03 RESALE FORM

Before we can leave sales tax off your invoices, we need your state's resale form on file with your resale number on it. We send you the form for your state with our details already filled in. You add your resale number (in California that is your seller's permit number), your business details and a signature, then email it back to hello@swipsband.com. It takes a few minutes and we keep it on file for every order after that.

A few states, Florida among them, issue a resale certificate to the retailer instead of using a form. If yours does, email us a copy of your current certificate and that is all we need.

04 SHIPPING

We pack your order and hand it to the carrier within 2 business days, shipping from Newport Beach, California. On a prepaid order the 2 days start when your payment lands. On a Net 30 order they start at order confirmation, which is the email confirming your quantities, pricing and ship date.

Ground freight is **free on orders of \$750 or more**. Below \$750 we bill actual ground cost. Title and risk of loss pass to you when the carrier picks up.

05 INSPECTION AND CLAIMS

Check your shipment when it lands. Report a shortage or shipping damage within **5 business days** of delivery and send photos. Report a manufacturing defect within **30 days** of delivery. We replace the units or issue credit, whichever we choose.

06 RETURNS

Every order is final except for the claims in Section 05. We do not take back unsold or overstocked product.

These terms govern your wholesale orders and replace the consumer refund and returns policies published on swipsband.com.

Nothing comes back without a return authorization number from us. Product shipped to us without one gets refused. Authorized returns travel freight prepaid in the original packaging.

07 PRICING AND WHERE YOU SELL

Sell Swips in your shop and on your own club website. Do not advertise or sell below **\$22.00** for the wristband 2-pack or **\$6.00** for the refill 2-pack.

Do not list Swips on Amazon, eBay, Walmart Marketplace or any other third party marketplace. Sell the product in our packaging. Do not repackage, relabel or split a 2-pack.

Break these and we suspend the account.

08 BRAND USE

Use the Swips name, logo and product photography to sell the product. Ask us first before you alter the logo or make a product claim we have not made ourselves. This permission ends when the account ends.

09 WARRANTY

We warrant the product against manufacturing defects for 30 days from delivery. That is the only warranty we give. Rosin is a consumable. The insert wears down with use, which is normal and not a defect.

10 ACCOUNT

No exclusivity and no protected territory unless we sign a separate agreement. Either of us can close the account with 30 days written notice. Open invoices survive.

11 STOCK AND BACKORDERS

If we cannot fill your whole order from stock, we tell you when we confirm it and you choose whether to wait or take what is on hand. We never invoice for units we cannot ship.

HOW TO ORDER

1. Email hello@swipsband.com with the quantities you want.
2. We reply within two business days, usually the same day, and confirm quantities, pricing and your ship date.
3. We email you a Shopify invoice. On your first order, pay it and we ship within two business days.
4. From your second order on, we ship within two business days of confirmation and the invoice follows on Net 30.

WHAT WE NEED FROM YOU

- Your state's resale form, filled in with your resale number and signed. If your state issues a resale certificate instead, a copy of that.
- A shipping address and the name of whoever receives the freight.
- The email address that should get your invoices.
